**OVERTIME**

On regular work days from Monday through Friday, time and one-half (1-1/2) shall be paid for overtime worked in excess of eight (8) hours in any one day. Time and one-half (1-1/2) shall be paid for the first eight (8) hours worked on Saturdays unless Saturday is a make-up day per Section 7 (c).

Double (2) time shall be paid for all overtime worked after twelve (12) hours Monday through Friday, all overtime worked after 8 hours on Saturdays and for all time worked Sundays and holidays.

**TRAVEL PAY**

“Published Federal Reimbursement Rate” per mile for all miles fifty (50) miles and beyond the traveling center or employees residence.

Refer to “Travel Expense/Travel Centers” section of the Cement Masons Master Labor Agreement.

## **EXPENSE OUT OF TOWN**

\$75.00 per diem. Refer to “Expense Out of Town” section of the Cement Masons Master Labor Agreement.

## **PUBLIC WORKS**

If an agency publishes wage and fringe benefit rates for a specific job or project which are less than the wage and fringe benefit rates set forth in this Agreement, the Individual Employer may utilize the wage rates, fringe benefit rates and other applicable working conditions established for that specific job or project set forth in the bid documents.

If no wage and fringe benefit rates are set forth in the bid documents for a specific job or project, the Union shall, upon an Individual Employers request, establish wage rates, fringe benefit rates and working conditions for that specific job or project pursuant to Section 18 of the NAEC Cement Masons Master Labor Agreement.

## **PARKING**

In the event parking facilities are not available within three (3) blocks of a jobsite, the Employer will provide such facilities and the Employer shall have the right to designate parking areas to be used. Where, because of congested parking conditions it is necessary to use public facilities, the Employer shall reimburse the employee for the cost of such parking upon being presented with a receipt or voucher certifying to the cost thereof; such reimbursement to be made on a weekly basis or at the conclusion of the project, whichever occurs earlier. The area covered by this Agreement shall be the City of Sacramento, City and County of San Francisco, and the Counties of Alameda, San Mateo, Marin, Contra Costa, and Santa Clara.

## **HOLIDAYS**

The holidays observed are New Year’s Day, Martin Luther King Day, Presidents’ Day, Decoration Day (Memorial Day), Independence Day (Fourth of July), Labor Day, Thanksgiving Day, the day after Thanksgiving and Christmas Day. Holidays falling on Sunday shall be observed on the following Monday.
