OVERTIME

One and one-half (1-1/2) the regular straight time hourly rate shall be paid for all work on Saturdays (except on make-up days) and before a shift begins and after it ends. Double the regular straight time hourly rate shall be paid for all work on Sundays, holidays, and as provided for by state law. Men working a complete shift of shift work on Saturdays, Sundays, and holidays shall be paid eight (8) hours of pay at the appropriate overtime rate for seven (7) hours of work on the second and third shifts only.

HOLIDAYS

The holidays observed are Saturdays, Sundays, New Year's Day, Presidents' Day, Memorial Day, Independence Day (Fourth of July), Labor Day, Thanksgiving Day, the day after Thanksgiving Day and Christmas Day. Holidays falling on Sunday shall be observed on the following Monday. Holidays falling on Saturday shall be observed on the preceding Friday.

NOTE: Martin Luther King, Jr. Day will become a recognized holiday when and if the five (5) basic crafts adopt it as a holiday.
